Glossary of Acronyms, Terms, and Abbreviations

ABC –Approved Budget for the Contract.

BAC – Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the basis for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR – Bureau of Internal Revenue.

BSP – Bangko Sentral ng Pilipinas.

Consulting Services – Refers to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

CDA - Cooperative Development Authority.

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

CIF – Cost Insurance and Freight.

CIP – Carriage and Insurance Paid.

CPI – Consumer Price Index.

DDP – Refers to the quoted price of the Goods, which means “delivered duty paid.”

DTI – Department of Trade and Industry.

EXW – Ex works.

FCA – “Free Carrier” shipping point.

FOB – “Free on Board” shipping point.

Foreign-funded Procurement or Foreign-Assisted Project–Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

Framework Agreement – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

GFI – Government Financial Institution.

GOCC –Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term “related” or “analogous services” shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

GOP – Government of the Philippines.

GPPB – Government Procurement Policy Board.

INCOTERMS – International Commercial Terms.

Infrastructure Projects – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways,

airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

LGUs – Local Government Units.

NFCC – Net Financial Contracting Capacity.

NGA – National Government Agency.

PhilGEPS - Philippine Government Electronic Procurement System.

Procurement Project – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

PSA – Philippine Statistics Authority.

SEC – Securities and Exchange Commission.

SLCC – Single Largest Completed Contract.

Supplier – refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. (Item 3.8 of GPPB Resolution No. 13-2019, dated 23 May 2019). Supplier as used in these Bidding Documents may likewise refer to a distributor, manufacturer, contractor, or consultant.

UNDER ITB NO. PB21-11-011TAGa-12**

1. The Philippine Amusement and Gaming Corporation (PAGCOR), through the PAGCOR's Corporate Budget for CY 2021 intends to apply the sum of Twenty-Seven Million Pesos (PhP27,000,000.00), VAT Exclusive, Zero-Rated Transaction, being the total ABC to payments under the contract for the **Procurement of Hotel Room Accommodations, All Other Hotel Amenities and F&B Services For Customers/Guests (VVIP) Of Casino Filipino-Tagaytay.**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PAGCOR now invites bids for the above Procurement Project. Delivery of Goods and Services is required for a period of three (3) years, commencing from the date of receipt of the winning bidder of the Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instruction to Bidders)
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from PAGCOR and interested bidders may inspect and obtain further information from the Procurement Section (PS), acting as the BBAC Secretariat, of PAGCOR and/or inspect the Bidding Documents at the Procurement Section, Third (3rd) Floor, Casino Filipino – Tagaytay, Km 60, Aguinaldo Highway, Kaybagal South, Tagaytay City during office hours of PAGCOR from 9:00 a.m. to 5:00 p.m.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **December 17, 2021 (Friday) to January 10, 2022 (Monday)** from the given address and website(s) below and upon payment of Twenty-Five Thousand Pesos (PhP25,000.00) for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

PAGCOR shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means.

Prospective bidders may also download the Bidding Documents free of charge from www.pagcor.ph and www.philgeps.gov.ph and may be allowed to submit bids provided that bidders pay the applicable fee of the Bidding Documents not later than the deadline for the submission and receipt of bids.

In effecting payment for the Bidding Documents, prospective bidders shall present either the Payment Slip, which may be secured from the Procurement Section, or a copy of this Invitation to Bid (ITB) to Finance Section, Third (3rd) Floor, Casino Filipino – Tagaytay, Km 60, Aguinaldo Highway, Kaybagal South, Tagaytay City.

6. The PAGCOR will hold a **Pre-Bid Conference on December 27, 2021 (Monday) at 11:00 am** at the Former Chine Restaurant, Third (3rd) Floor, Casino Filipino – Tagaytay, Km 60, Aguinaldo Highway, Kaybagal South, Tagaytay City, which shall be open to prospective bidders.
7. Bids must be duly received by the BBAC Secretariat through manual submission on or before **January 10, 2022 (Monday) at 11:00 am** at the Former Chine Restaurant, Third (3rd) Floor, Casino Filipino – Tagaytay, Km 60, Aguinaldo Highway, Kaybagal South, Tagaytay City. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **January 10, 2022 (Monday) at 11:00 am** at the former Chine Restaurant at the Third (3rd) Floor, Casino Filipino – Tagaytay, Km 60, Aguinaldo Highway, Kaybagal South, Tagaytay City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Bidders shall bear all costs associated with the preparation and submission of their bids, and PAGCOR will in no case, be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

Bidders should note that PAGCOR will accept bids only from those that have paid the applicable fee for the Bidding Documents.

PAGCOR assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.

In accordance with Government Procurement Policy Board (GPPB) Circular 06-2005 - Tie-Breaking Method, the Bids and Awards Committee (BAC) shall use a non-discretionary and non-discriminatory measure based on sheer luck or chance, which is "DRAW LOTS," in the event that two (2) or more bidders have been post-qualified and determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final bidder having the LCRB, based on the following procedures:

- a) In alphabetical order, the bidders shall pick one rolled paper.
 - b) The lucky bidder who would pick the paper with a "CONGRATULATIONS" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.
11. The PAGCOR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

Section II. Instructions to Bidders

1. Scope of Bid

The Procuring Entity, Philippine Amusement and Gaming Corporation (PAGCOR), wishes to receive Bids for the **Procurement of Hotel Room Accommodation and All Other Hotel Amenities and F&B Services For Customers/Guests (VVIP) Of Casino Filipino-Tagaytay** under ITB No. PB21-11-011TAGa-12 with a total Approved Budget for the Contract (ABC) in the amount of **Twenty Seven Million Pesos (PhP27,000,000.00)**, VAT Exclusive, Zero-Rated Transaction.

The Procurement Project (referred to herein as "Project") is composed of one (1) lot, the details of which are described in Section VII (Technical Specifications).

2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for CY 2021 in the amount of **Twenty Seven Million Pesos (PhP27,000,000.00)**, VAT Exclusive, Zero-Rated Transaction.
- 2.2. The source of funding is the Corporate Operating Budget – PAGCOR's Corporate Budget for CY 2021.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. Foreign ownership limited to those allowed under the rules may participate in this Project.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least Fifty percent (50%) of the ABC in the amount of **Six Million Seven Hundred Fifty Thousand Pesos (Php13,500,000.00)**.

OR

In view of the determination by PAGCOR that imposition of the provisions of Section 23.4.1.3 of the IRR of RA 9184 will likely result to failure of bidding that will defeat the purpose of public bidding”, the Bidder should comply with the following requirements:

- a) Completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least *Fifty* percent (50%) in the case of non-expendable Supplies and/or Services of the ABC for this Project for (single lot)

OR;

Completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least Fifty percent (50%) in the case of non-expendable Supplies and/or Services of the ABC each lot participated (for several lots); and

- b) The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above.

- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

6. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

7. Subcontracts

- 7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than twenty percent (20%) of the Project.

The Procuring Entity has prescribed that Subcontracting is not allowed.

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on **December 27, 2021, Monday, 11:00 am** at the Former Chine Restaurant, Third (3rd Floor), Casino Filipino – Tagaytay , Km 60, Aguinaldo Highway, Kaybagal South, Tagaytay City, which shall be open to prospective bidders.

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 10.2. The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed within three (3) years prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

11. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.

- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

12. Bid Prices

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:
 - a. For Goods offered from within the Procuring Entity's country:
 - i. The price of the Goods quoted EXW (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable);
 - ii. The cost of all customs duties and sales and other taxes already paid or payable;
 - iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
 - iv. The price of other (incidental) services, if any, listed in e.
 - b. For Goods offered from abroad:
 - i. Unless otherwise stated in the **BDS**, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the **BDS**. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
 - ii. The price of other (incidental) services, if any, as listed in **Section VII (Technical Specifications)**.

13. Bid and Payment Currencies

- 13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for

purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.

13.2. Payment of the contract price shall be made in Philippine Pesos.

14. Bid Security

14.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.

14.2. The Bid and bid security shall be valid for one hundred twenty (120) calendar days from the date of the Submission, Opening and Preliminary Examination of Bids. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

15. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

16. Deadline for Submission of Bids

16.1. The Bidders shall submit on the specified date and time and either at its physical address as indicated in paragraph 7 of the **IB**.

17. Opening and Preliminary Examination of Bids

17.1. The BBAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

- 17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

18. Domestic Preference

- 18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "*passed*," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.
- 19.2. If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case maybe. In this case, the Bid Security as required by **ITB** Clause 15 shall be submitted for each lot or item separately.
- 19.3. The descriptions of the lots or items shall be indicated in **Section VII (Technical Specifications)**, although the ABCs of these lots or items are indicated in the **BDS** for purposes of the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184. The NFCC must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder.
- 19.4. The Project shall be awarded as One Project having several items grouped into several lots, which shall be awarded as separate contracts per lot.
- 19.5. Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. For bidders submitting the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

20. Post-Qualification

- 20.2. Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest/Single Calculated Bid, the Bidder shall submit its latest income

and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law and stated in the **BDS**.

Del Pilar cor. Pedro Gil St. Malate, Manila, represented by its Chairman and Chief Executive Officer, **ANDREA D. DOMINGO**, hereinafter referred to as "**PAGCOR**";

-and-

_____ a Corporation duly organized and existing under the laws of the Republic of the Philippines, with office address at _____ represented by its _____, duly authorized for this purpose, as per _____, hereto attached as "*Annex A*". herein after referred to as the "**CONTRACTOR**".

Each of **PAGCOR** and **CONTRACTOR** may be referred to herein as a "**PARTY**" and collectively as "**PARTIES**"

The **PARTIES** warrant that they are duly organize, registered, validly existing and in good standing under the laws of the Republic of the Philippines, and that the **PARTIES** and their representatives are capable and have the requisite power, authority, permits, clearances and licenses, to enter into this Service Contract and to perform the Services and all of their obligations under this Service Contract.

RECITALS:

WHEREAS, **PAGCOR** requires Procurement of Three (3) Years Hotel Room Accommodations, All Other Hotel Amenities and F&B Services for Customers/Guests VVIP of CF-Tagaytay under ITB No. Pb21-11-011TAGa-12 (the "Service").

WHEREAS, pursuant to Section 50 (a) of the Implementing Rules and Regulations (IRR) of Republic Act (R.A) 9184, the **CONTRACTOR** has submitted a responsive proposal to undertake the said Services and **PAGCOR** has accepted the proposal of the **CONTRACTOR**, subject to the terms and conditions hereunder stipulated.

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements hereunder specified by these presents, **PAGCOR**, and the **CONTRACTOR** hereby enter into the Service Contract under the following terms, conditions and stipulations:

I.SCOPE OF SERVICES

The **CONTRACTOR** undertakes to provide the Services, specifically, the provision of room accommodations, food and beverages and the incidental services, in accordance with the hotel rates and menu as attached herein as “*Annex B*” and technical specifications:

QUALIFICATIONS:

2. The **CONTRACTOR** has the ambiance of a 4 star hotel and restaurant.
3. The **CONTRACTOR** has a proven track record in the hotel & restaurant. Industry for at least eight (8) years.
4. The restaurant of the **CONTRACTOR** is able to serve various Asian and International Cuisines.
5. The restaurant of the **CONTRACTOR** can accommodate a minimum of 100 person seating capacity.
6. The **CONTRACTOR** shall allocate **eight (8) rooms** for weekdays (Sunday-Thursday) and **six (6) rooms** for weekends (Friday & Saturday) for reservation purposes. Additional rooms may be reserved subject to availability and advance notice.
7. The **CONTRACTOR** should serve complimentary breakfast for two (2) per room per day.
8. The **CONTRACTOR** shall exercise the required diligence in the supply of room accommodation to the clientele of **PAGCOR**.
9. The **CONTRACTOR** must be able to meet the demand of the branch in connection with the goods/services to be provided to its client.
10. The **CONTRACTOR** has the capability to provide first class room accommodation and food and beverages at a reasonable cost.
11. The **CONTRACTOR** should provide the following hotel room standard set-up but not limited to:
 - Lavatory with hot and cold water
 - Bath and shower with hot and cold water,
 - Personal refrigerator
 - LED TV
 - Free Wi-fi connection
 - Coffee table and chair
 - Dresser
 - Luggage rack
 - Keyless entry card
 - Individual reading lamp

- Safety deposit box
- Complimentary coffee and tea-making facility and bottled water
- Use of Gym facilities to **PAGCOR** Officers

HOTEL RATES

1. The **CONTRACTOR** shall provide special discounted room rates to **PAGCOR** and its authorized representatives, as follows:

3. The **CONTRACTOR** shall not amend the room rates without prior written consent of **PAGCOR**. The prices herein agreed shall not be subject to any increase or upward adjustment for any reason or cause whatsoever for the duration of the Contract.
4. On Peak Days (such as Holy Week, Christmas Season, Public Holidays including the days prior or after) a surcharge will be added to the weekend rates and will be applicable on these dates.
5. Above rates are inclusive of the applicable government taxes and service charge and breakfast for two (2) persons.
6. Above rates are applicable for Single or Twin Occupancy.
7. The **CONTRACTOR** shall extend 20% discount on other amenities offered by the establishment, as follows:
 - 20% discount Food and Beverages (not applicable in conjunction with other promos and coupons)
 - 20% discount Spa and Massage Services
 - 20% discount Laundry and Dry-Cleaning Services
 - and special discounted rates on Recreational facilities, Function room and Banquet Facilities only.
8. The goods and services provided by the **CONTRACTOR** shall comply with generally accepted tourism industry and **PAGCOR's** standards and shall always take into considerations the special preferences of **PAGCOR**, its customers, clients and/or guests.

ROOM RESERVATION PROCEDURE

1. Prior reservations are required and subject to availability.
2. All reservations must be covered by a duly signed Advance Room Reservation Form and **PAGCOR's** Letter of Authority (LOA) and must be scanned e-mailed with reference or tracking number. Original blue copy will be forwarded on the next day morning.

The following details are required to be included in the letter of Authority and duly signed by the authorized signatories of **PAGCOR**.

- a. Date, Name of guests and Companions, Check-in, and Check-out date/Time
 - b. Room type (Superior, Deluxe, Premier, etc.) Number of rooms required.
 - c. Charges to be settled by **PAGCOR** (i.e., Rooms and F&B).
 - d. Unsettled charges left by the guest and did not pass by the Front Office to check-out.
 - e. The LOA must be duly signed by authorized personnel of **PAGCOR**.
3. Only guests with prior reservations (with LOA and advance reservation form) will enjoy the **PAGCOR** special rates and will be allowed to check-in using these special rates.
 4. All **PAGCOR** endorsed room reservations are chargeable to **PAGCOR** and are subject to the payment terms in this agreement.
 5. The official check-in time is 2:00 pm on the day of the arrival. Request for an early check-in is subject to availability.
 6. Official check-out time is at 12:00 noon on the day of departure. Check-out after 3:00 pm and before 6:00 pm shall be charged half day rate while check-out after 6:00 pm shall be charged full rate.
 7. In the event of guest's extension of stay, **PAGCOR** will forward to **CONTRACTOR's** Front Office a Letter of Authority (LOA) for extended stay or Notice of Revision a day prior to extension date which will be subject to room availability. Failure to send the LOA on the prescribed date will result to the extension to be charged at the Hotel's prevailing published rates and charged to the guest's personal account. The usual credit card requirements will be secured from the guest prior to the extension of stay.
 8. The **CONTRACTOR** requires a deposit amounting to Two Thousand Pesos (PhP2,000.00) upon check-in from all guests either in cash or credit cards imprint to cover incidentals to be incurred during their stay in the hotel. Incidental deposit shall only be waived if it is specifically indicated on the Letter of Authority (LOA) and all bills are chargeable to **PAGCOR**.
 9. **PAGCOR** special rate and discount privilege maybe extended to **PAGCOR** Officers and staff only upon presentation of a valid identification prior to check-in subject to

space availability. Settlement shall be on a personal account upon check-in or during the availing of discount privilege.

CANCELLATION AND NO-SHOW POLICIES

The cancellation and no-show policy will be applied on days when the Hotel occupancy is running 75% or higher, provided that **PAGCOR** will be advised of the occupancy in writing at least (4) days before the concerned dates.

REVISION/NO SHOW

 - c. Prior reservation is required and will be subject to availability.
 - d. Two (2) months validity period.
 - e. Not valid on weekends, peak periods, and holidays.
 - f. Official check-in time is 2:00 pm and check-out time is 12:00 noon.
 - g. Exclusive of breakfast and/or any other meal.
2. **PAGCOR** shall give the following privilege to **CONTRACTOR** and its guests, to wit.
 - Free entrance to all Hotel guests
 - Free Bet Certificates (FBC) worth PhP300.00 to all hotel guests.
 - Shuttle service from Hotel to Casino and vice versa for all Hotel guests
 - Provide a space where **CONTRACTOR** could display its flyers at the Lobby every board for activity poster.
3. In exchange of these privileges, **CONTRACTOR** will extend the following:

- Promotions of the activities/shows at the Hotel; and
- **PAGCOR** Marketing Staff will include the activities/shows during their sales activities and events.

OTHER TERMS AND CONDITIONS

1. In the event that the **CONTRACTOR** fails to comply with any of its undertakings, as set forth in the Service Contract, **PAGCOR** shall be released from its obligations under this Service Contract, without prejudice to its rights of restitution, recovery and damages.
2. This Service Contract, and all the rights and interests herein, may not be assigned or sub-contracted to another without the consent of the other **PARTIES**.
3. In the event that facts and circumstances arise or are discovered which render this Contract disadvantageous to the Government, as determined by **PAGCOR**, the **PARTIES** hereto agree to immediately re-negotiate its terms and conditions, or at the option of **PAGCOR**, terminate the same.

This Service Contract constitutes the entire agreement between the **PARTIES** pertaining to the subject matter contained in it and supersedes all prior and contemporaneous contracts, representations, warranties, and understandings of the **PARTIES**. No supplement, variation or amendment to this Service Contract shall be binding unless executed in writing by all the **PARTIES** thereto.

II. BUDGET and SCHEDULE OF PAYMENT

1. The total budget for this Service Contract shall be **NINE MILLION PESOS (PhP9,000,000.00)**, VAT Exclusive, Zero Rated Transaction for the period of one (1) year or **TWENTY SEVEN MILLION PESOS (PhP27,000,000.00)**, VAT Exclusive, Zero Rated Transaction, **for three (3) years** (the "Budget").
2. Payment shall be based on actual consumption and billing and shall be subject to the appropriate withholding taxes.
3. **PAGCOR** shall not be under any obligation to pay the **CONTRACTOR** the entire amount of the Budget. Moreover, the aggregate billings under this Contract shall not exceed the total budget.
4. The **CONTRACTOR** shall submit Statement of Account (SOA) or billing on a weekly basis.
5. All bills/charges must be settled within thirty (30) days upon receipt of the hotel's Statement of Account with attached documents duly signed by the registered guest/s.
6. A penalty surcharge of 3% shall be imposed for accrued past due accounts on a monthly basis. **PAGCOR** is only given three (3) days upon receipt of billing statement to review and to return the billing statement for any discrepancy.

7. The Hotel only accepts Cash and Company Cheques as form of settlement. Company Cheque payment has to be made payable to: _____.

III. CONTRACT TERM

1. This Contract shall be for a period of three (3) years, which shall be effective from the date specified in the Notice to Proceed. However, this Contract shall be automatically terminated if the Budget is exhausted before the termination date.
2. **PAGCOR** may terminate this Contract with or without cause, without need for judicial intervention, and without incurring any obligation whatsoever, upon thirty (30) days written notice to the **CONTRACTOR**.
3. Should the **CONTRACTOR** incur delay in the performance of its obligations, **CONTRACTOR** shall pay a penalty of one-tenth of one percent (1/10 of 1%) of the total cost of the Contract for each day delay, including Sundays and Holidays, beyond the specific period. The Maximum deduction shall be ten percent (10%) of the amount of the Contract. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the Agreement, **PAGCOR** shall have the option to rescind the Contract, without prejudice to other courses of action and remedies open to it.
 4. In case the **CONTRACTOR** still fails to deliver the Services after the lapse of thirty (30) days from the supposed date of implementation as provided for in this Contract, **PAGCOR** shall have the option to terminate the Contract, without prejudice to other courses of action and remedies open to it.

IV. NO EMPLOYER-EMPLOYEE OR AGENCY/PARTNERSHIP RELATIONSHIP

1. There shall be no employer-employee relationship between **PAGCOR** and the employees of the **CONTRACTOR**. The **CONTRACTOR** shall have the entire charge, control and supervision of the Services herein agreed upon. The personnel and all persons allowed by it to have access to **PAGCOR**'s premises, for any injury which may be caused to any person or property while remaining either casually or in business in any part of **PAGCOR**'s premises.

Any accident, injury or sickness of any kind, or death that may occur at any agent, personnel of the **CONTRACTOR** consequent to the performance of the Service under this service Contract shall be the **CONTRACTOR**'s sole responsibility. The **CONTRACTOR** further bids itself to indemnify and hold **PAGCOR** free and harmless from any claim on account of the aforementioned injuries or damages.
2. Any offense committed by any of the **CONTRACTOR**'s personnel shall constitute a breach of this Service Contract. **PAGCOR** shall communicate to the **CONTRACTOR** all instances of such breach for immediate and appropriate action by the **CONTRACTOR**.

3. The **CONTRACTOR** shall comply with all of obligations as an employer under the Labor Code, its implementing rules and regulations and all other applicable laws and regulations. Non-compliance therewith shall be for its exclusive risk and responsibility and shall constitute a violation of and a ground for the termination of this Service Contract.
4. The relationship between the **PARTIES** shall be limited to the performance of the Services as stipulated under this Service Contract. Nothing herein shall be construed to create a general partnership between the **PARTIES**, or to authorize any **PARTY** to bind the other, except as set forth in this Service Contract, or to borrow money on behalf of another **PARTY**, or to use the credit of any **PARTY** for any purpose.

IV. WARRANTIES, CLEARANCES, PERMITS, LICENSES and TAXES

1. The **CONTRACTOR** warrants that there are no actions, suits or proceedings pending or threatened, which may have a material adverse effect on its ability to fulfill its obligations under this Contract or on its operations, business, properties, assets, or business conditions.
2. All taxes, amounts, claims and expenses pertaining to clearances, licenses, permits, registrations, or renewal thereof, required by **PAGCOR** or the appropriate government entities for the Services to be performed under this Service Contract shall be for the exclusive account of **CONTRACTOR**.
3. The **CONTRACTOR** shall pay its taxes in full and on time. 2. The **CONTRACTOR** hereby holds **PAGCOR** its guests, corporate affiliates, directors, officers, employees and agents free and harmless from any and all actions or liabilities arising out of this Service Contract, including, without being limited to, claims for unpaid and back wages, regularization, other terms and conditions of employment, as well as civil and criminal liabilities that the **CONTRACTOR** and/or **PAGCOR** may incur as a result of, or arising out of, the conduct and/or pursuit of Services and to indemnify the **PAGCOR** from and against the costs of defending any action, suit or proceeding, including legal fees or other expenses incurred in relation to any such claims mentioned above.
3. The **CONTRACTOR** shall indemnify and shall hold **PAGCOR**, its directors, officers, employees, agents, customers and guests and corporate affiliates and any employee or agent thereof (each of the foregoing, being hereinafter referred to individually as the

“Indemnified Party”) free and harmless against any and all liability to third parties (other than liability solely the fault of the indemnified party) arising from the negligence of the **CONTRACTOR** or its agents including (but not limited to) the violation of any third party’s trade secret, proprietary information, trademark, copyright or patient rights in connection with **PAGCOR’s** use of the **CONTRACTOR’s** services.

The exclusive venue provision shall apply even in case for declaration of nullity of this Contract in the entirety or in part.
3. In the event that the facts and circumstances arise or be discovered which render this agreement disadvantageous to the government, the **PARTIES** hereto agreed to immediately negotiate its terms and conditions.
