BBAC RESOLUTION DECLARING THE LOWEST CALCULATED & RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT TO LOPUE'S MANDALAGAN CORPORATION

WHEREAS, the Logistics Management Section (LMS) has a requirement for the Supply and Delivery of Food Supplies for Employees under SV21-04-006BAC, with an approved budget for the Contract amounting to: Three Hundred Ninety-Eight Thousand Eight Hundred Eight Pesos and 27/100 (PhP398,808.27) Vat Exclusive, Zero Rated Transaction, as approved by the Board of Directors last January 28, 2021;

WHEREAS, the use of Negotiated Procurement (Small Value) was approved by the Board of Directors on January 28, 2021, upon recommendation by the Branch Bids and Awards Committee CF-Bacolod in accordance with Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 since the amount involved for said project is within the threshold of One Million Pesos (PhP1,000,000.00) as provided under Annex "H" of the same IRR of R.A. 9184;

WHEREAS, the Request for Quotation (RFQ) for the aforesaid requirement was posted in the Philippine Government Electronics Procurement System (PhilGeps) and in a conspicuous place within the vicinity of Casino Filipino – Bacolod from April 14, 2021 to April 22, 2021. Copies of the Request for Quotations (RFQ) were also sent to prospective bidders through electronic mail and fax such as **LOPUE'S MANDALAGAN CORP., ANG DESIGN STUDIOS, INC., AND NEWBRIDGE ELECTRICAL ENTERPRISES.**

WHEREAS, After Nine (9) calendar days posting, two (2) bidders submitted a sealed quotation, **Loupe's Mandalagan Corporation and Ang Design Studios, Incorporated.**

WHEREAS, After the Opening and Preliminary Examination of Envelopes (Eligibility, Technical and Financial Component), the two (2) bidders got a "passed rating";

WHEREAS, the two (2) bidders complied with the bidding requirements as prescribed in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184. After completing the tabulation, hereunder the financial quotations of the qualified bidders, as read:

To recommend for approval of the Branch Manager, CF-Bacolod, as duly delegated by the Board of Directors of PAGCOR, to award the contract to **LOPUE'S MANDALAGAN CORPORATION** in the contract amount of **One Hundred Ninety-Eight Thousand Six Hundred Thirty-Two Pesos and 50/100 (Php198,632.50) Vat Exclusive, Zero Rated Transaction.**






