WHEREAS, this refers to the Negotiated Procurement (Two-Failed Biddings) for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. FB21-10-001DAVa-11;

WHEREAS, the following public biddings were declared a "Failure of Bidding" by the Branch Bids and Awards Committee (BBAC), CF – Davao due to the following reasons:

WHEREAS, on November 4, 2021, the Acting Branch Manager approved the re-conduct of Negotiated Procurement (Two-Failed Bidding) for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. FB21-10-001DAVa-11;

WHEREAS, the Request for Quotations (RFQ) for the aforesaid requirement was posted at the websites of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of Casino Filipino – Davao from November 5 to 18, 2021;

WHEREAS, copies of the RFQ were also sent through email and fax to seven (7) prospective bidders;

WHEREAS, on the deadline for the Submission of Best Offer on November 18, 2021, the BBAC of CF- Davao declared a Failure of Negotiated Procurement (Two Failed Bidding), pursuant to Section 35.1 (a) of the IRR of R.A. 9184, which provides that:

Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:

b) No bids are received;

WHEREAS, in view of the foregoing, BBAC of CF-Davao respectfully recommends the following resolutions for the information or further instruction, if any, of the Acting Branch Manager, as duly delegated by the Board of the Directors:

1. Declaration of a "Failure of Bidding" for Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. FB21-10-001DAVa-11, pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
2. Re-conduct of Negotiated Procurement (Two-Failed Biddings) consisting of Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite, with re-posting as provided for in Section 21.2 of the IRR of R.A. 9184.
