**RESOLUTION DECLARING FAILURE OF PUBLIC BIDDING AND THE CONDUCT OF REBIDDING**

**WHEREAS**, the Bids and Awards Committee (BAC) 1 has been tasked to handle the procurement of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Procurement Processing Request, approved Annual Procurement Plan (APP) for CY 2021, quotations and other pertinent documents were received on May 25, 2021, by the Procurement Department (PD), acting as the BAC Secretariat;

**WHEREAS**, in the Pre-Procurement Conference held last June 23, 2021, the BAC 1 together with the representatives of the end-user, SOG5, reviewed and evaluated all the documents presented, including the Terms of Reference (TOR) integrated in the Bidding Documents;

**WHEREAS**, in the same meeting, the BAC 1 agreed to proceed with the finalization of the bidding documents and posting of the requirement using the amount of Eight Million Fifty-Two Thousand Pesos (PhP8,052,000.00), VAT Exclusive, Zero-Rated Transaction, as the ABC to be posted;

**WHEREAS**, the Invitation to Bid (ITB) was posted from July 27, 2021 to August 16, 2021 at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of PAGCOR Corporate Annex Office, and also sent through email to prospective bidders listed in the PAGCOR's Registry of Suppliers;

**WHEREAS**, in the Pre-Bid Conference held on September 4, 2021, the BAC 1 discussed the salient procedures for the conduct of public bidding and the contents of the Bidding Documents to the lone participating bidder who attended the conference, KBG Catering Services;

**WHEREAS**, due to the declaration of Community Quarantine, the procurement of the project was postponed from August 6, 2021 until September 8, 2021;

**WHEREAS**, no bidder bought the cost for the sale of the Bidding Documents;

WHEREAS, on September 21, 2021, during the deadline for the Submission and Receipt of Bids, no bidder submitted its bid;

WHEREAS, in the same meeting, the BAC 1 declared a Failure of Bidding since no bid was received;

WHEREAS, the end-user signified that they intend to re-conduct the procurement process, using the same budget and TOR;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC) 1, hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare a Failure of Bidding for Procurement of Food and Beverages for Casino Guests and PAGCOR Officers of Town Center Satellite for a Period of Three (3) Years under ITB No. PB21-06-033COR, pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, since no bid was received, and
- b) To conduct a rebidding for Procurement of Food and Beverages for Casino Guests and PAGCOR Officers of Town Center Satellite for a Period of Three (3) Years with re-posting, pursuant to Section 21.2 of the 2016 Revised IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates, pursuant to Section 35.2 of the same IRR of RA 9184.


