BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE AND CONDUCT OF RE-BIDDING FOR SUPPLY AND DELIVERY OF FOOD AND BEVERAGES (F&B) FOR VARIOUS BRANCH MARKETING EVENTS UNDER ITB NO. PB21-10-003DAV

WHEREAS, the Branch Bids and Awards Committee (BBAC) of Casino Filipino - Davao has been tasked to handle the procurement requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, the Procurement Processing Request (PPR), approved Annual Procurement Plan (APP) 2021 dated May 20, 2021, and Terms of Reference, and Quotations were received by the Branch Bids and Awards Committee (BBAC) Secretariat on October 13, 2021;

WHEREAS, in a Pre-Procurement Conference held on October 18, 2021, the BBAC CF-Davao and representative from the end-user, Marketing Section, reviewed and evaluated all the documents presented, including the terms of reference/ scope of work integrated in the Bidding Documents;

WHEREAS, the Invitation to Bid was posted at the websites of PAGCOR and the Philippine Government and Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Davao from October 20, 2021 to November 9, 2021, and also sent through email and fax to prospective bidders;

WHEREAS, on October 28, 2021, no bidder attended the Pre-bid Conference;

WHEREAS, on the deadline for the Submission, Receipt, Opening and Preliminary Examination of Bids on November 9, 2021, no bidders submitted their bids during the scheduled time of submission;

WHEREAS, the BBAC of CF- Davao declared a Failure of Bidding in accordance with Section 35.1.a of the IRR of R.A. 9184, which states that:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:

a) No bids are received;

1. Declaration of a "Failure of Bidding" for the Supply and Delivery of Food and Beverages (F&B) for Various Branch Marketing Events under ITB No. PB21-10-003DAV pursuant to Section 35.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
2. Re-conduct of bidding for the for Supply and Delivery of Food and Beverages (F&B) for Various Branch Marketing Events with re-advertisement and/or re-posting, pursuant to Section 35.3 of the IRR of RA 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates.
