RESOLUTION DECLARING FAILURE OF RE-BIDDING AND RECOMMENDING APPROVAL BY THE ACTING BRANCH MANAGER FOR THE RESORT TO NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS) AND REVISION/UPDATING OF THE ANNUAL PROCUREMENT PLAN (APP) FOR CY 2021

WHEREAS, this refers to the public bidding for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. PB21-07-002DAV;

WHEREAS, the Branch Bids and Awards Committee (BBAC) CF-Davao has been tasked to handle the procurement of requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

WHEREAS, after the Opening and Preliminary Examination of Bids held on August 18, 2021, the BBAC declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

"Section 35. Failure of Bidding"

35.1. The BAC shall declare the bidding a failure when:

a) No bids are received; and

WHEREAS, the BBAC CF-Davao further recommend to conduct a re-bidding with re-advertisement and/or posting, pursuant to Section 35.3 of the IRR of RA 9184, after the

conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates;

WHEREAS, the Acting Branch Manager approved the conduct of re-bidding on August 23, 2021 for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. PB21-07-002DAVa-09;

WHEREAS, after the Opening and Preliminary Examination of Bids held on September 22, 2021, the BBAC declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

"Section 35. Failure of Bidding"


35.1. The BAC shall declare the bidding a failure when:

b) No bids are received; and

WHEREAS, in view of the foregoing, the Branch Bids and Awards Committee (BBAC) Casino Filipino - Davao resolved to recommend to the Acting Branch Manager, as duly delegated by the Board of the Directors, the approval of the following resolutions:

1. Declaration of a "Failure of Bidding" for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite under ITB No. PB21-07-002DAVa-09, pursuant to Section 35.1 (c) of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184; and
2. Conduct of Negotiated Procurement (Two-Failed Biddings) for the Supply and Delivery of One (1) Year Food and Beverages (F&B) for Casino Customers, Guests and Officers of Tagum Satellite with re-posting as provided for in Section 54.2 and Annex H (Consolidated Guidelines for Alternative Methods of Procurement) of the IRR of R.A. 9184, after the conduct of mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates and pursuant to Section 35.5 of the IRR of R.A. 9184 since there occurred two failed biddings; and
3. Revision/Updating of the 2021 Annual Procurement Plan (APP) to reflect the change in the Mode of Procurement from Competitive/Public Bidding to Negotiated Procurement (Two-Failed Biddings).
