**BBAC CF-DAVAO RESOLUTION RECOMMENDING APPROVAL FOR THE FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF THREE (3) YEARS FOOD AND BEVERAGES (F&B) FOR CASINO CUSTOMERS, GUESTS AND OFFICERS OF TAGUM SATELLITE UNDER ITB NO. CB22-00-001DAV AND RE-CONDUCT THEREOF**

**WHEREAS**, the Branch Bids and Awards Committee (BBAC) CF-Davao has been tasked to handle the procurement of requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) with the project details presented above;

**WHEREAS**, the Procurement Processing Request (PPR), approved Indicative Annual Procurement Plan (APP) for CY 2022, Technical Specifications and other pertinent documents were received by the Procurement Section (PS), acting as the BBAC Secretariat on December 6, 2021;

**WHEREAS**, in a Pre-Procurement Conference held last December 7, 2021, the BBAC CF-Davao together with the representative of the end-user, Customer Relations Section (CRS), reviewed and evaluated all the documents presented, including the technical specifications integrated in the Bidding Documents;

**WHEREAS**, the Invitation to Bid (ITB) was posted at the websites of PAGCOR and the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of CF-Davao from December 8 to 28, 2021;

**WHEREAS**, copies of the ITB were also sent to prospective bidders thru electronic mail copy furnished the representative from the end-user, CRS.

**WHEREAS**, after the Opening and Preliminary Examination of Bids held on December 28, 2021, no bidder submitted their bids and the BBAC CF-Davao declared a "Failure of Bidding" in accordance with Section 35.1 (a) of the Implementing Rules and Regulations (IRR) of RA 9184, which states:

*"Section 35. Failure of Bidding"*

35.1. *The BAC shall declare the bidding a failure when:*

*a) No bids are received; and*
